If you said yes to any two of these, you might qualify for the **Conservation Stewardship Program (CSP).** 



Our **Conservation Stewardship Program (CSP)** helps you build on your existing conservation efforts while strengthening your operation. Whether you are looking to improve grazing conditions, increase crop yields, or develop wildlife habitat, we can custom design a CSP plan to help you meet those goals. We can help you schedule timely planting of cover crops, develop a grazing plan that will improve your forage base, implement no-till to reduce erosion or manage forested areas in a way that benefits wildlife habitat. If you are already taking steps to improve the condition of the land, chances are CSP can help you find new ways to meet your goals.

No one knows more about your land than you do, and no one knows more about conservation than we do. Together we can develop a plan tailored to your land and your goals to help you increase productivity and protect the value of your land.

You don't have to be an expert with conservation practices to apply for CSP.

#### **Environmental Quality Incentives Programs (EQIP)**

EQIP is a voluntary conservation program available for agricultural producers and/or landowners. Program participants receive financial and technical assistance to implement conservation practices, or management activities like irrigation or nutrient management, that address natural resource concerns on their land. EQIP dollars can be used for soil health practices (e.g., cover crops, no-till, etc.), water quality practices, forestry management, etc.

Many applicants are interested in using funds to address soil erosion and water quality issues on their land; however, funds are also available for pasture and grazing land, confined livestock operations, manure management, organic producers, drainage water management, invasive plant control, and wildlife habitat improvement including monarch butterfly habitat development.

Payments are made to participants after conservation practices and activities identified in an EQIP plan of operations are implemented.

#### Wetlands Reserve Easement (WRE)

Under this easement program, we provide technical and financial assistance directly to private landowners and/or Indian tribes to restore, protect, and enhance wetlands through the purchase of a wetland reserve easement. These are offered under permanent (perpetuity) easements which NRCS pays 100% of the easement value for the purchase of the easement. Additionally, NRCS pays 100% of the restoration costs.

#### **Conservation Reserve Program (CRP)**

CRP encourages farmers to convert highly erodible cropland or other environmentally sensitive acreage to vegetative cover, such as grass waterways, native grasses, wildlife plantings, trees, filter strips and riparian buffers. Farmers receive an annual rental payment for the term of the contract. Cost sharing is provided to establish the vegetative cover practices.

If you feel like you are ready to take your conservation efforts to the next level – we are here to help. Contact us to develop a conservation plan on your land. We can then guide you to the funding program that best fits your needs. You can apply for these programs anytime throughout the year but there will be announced cutoff dates for ranking and funding opportunities.
