Sponsor & Vendor requests have been sent out.

- H. IASWCD Annual Conference Cooper updated the board on the resolutions. Only one resolution passed out of the Business Meeting on January 15, 2016 -the resolution from Daviess County SWCD in regards to allowing SWCDs to purchase food when events are being reimbursed by individuals or sponsors. \*UPDATE from 2-5-2016\* IASWCD is currently working with the State Board of Accounts to help make an administrative change to the "Special Districts" accounting manual, which is applicable to SWCDs. He also informed the board of the legislatures that they were able to see. He also had a great networking opportunity with Elkhart County NRCS/SWCD and looks hopeful to future collaborations with them.

- I. CRP Contribution Agreement Longenecker informed the board that the 2016 contract will be coming soon. 2015 we were able to bring in \$3,024. We are hopeful we can bring in this much or more in 2016.
- J. Cobus Creek Watershed Ivkovich gave an update that Wrasse and herself attended the steering committee meeting 1-6-16. # Farm Bill Program Updates

## **CRP 30 Year Celebration**

- The Conservation Reserve Program (CRP) was signed into law by President Ronald Reagan on December 23, 1985. The CRP is administered by the Farm Service Agency (FSA) with technical assistance, including conservation planning provided by NRCS and our partners, such as the local Soil and Water Conservation Districts, Indiana Department of Natural Resources and Indiana State Department of Agriculture.
- A joint agency media event was held on December 23 to kick off the anniversary of the CRP with
  former Senator Richard G. Lugar who served as a member of the U.S. Senate Agriculture Committee
  throughout his 36-year tenure. He served as Chairperson from 1995-2001, and is known as the author
  of the CRP. The CRP program was announced nationally on Lugar's Farm in Marion County,
  Indiana. The media call was recorded and will be available to conservation staff and SWCD
  supervisors.

# Agriculture Conservation Easement Program (ACEP)

- January 15 is the cutoff for ACEP applications (including Wetland Reserve Easements (WRE and Ag Lands Easements (ALE). Rankings will be scheduled prior to March 1 for all FY 2016 applications making the cutoff date. There is a new ranking form for 2016 and it has been posted to the NRCS website.

- Landowners with easements will be mailed their annual letters in early January which explain the monitoring process, compatible uses, etc.

## Conservation Stewardship Program (CSP)

A statewide review of all active EQIP and CSP contracts is underway that includes contracts
obligated from 2011 to 2015 that were contracted under an entity participant Employer ID
Number (EIN). Evaluations involve validation of contract DUNS numbers and SAM.gov
registration and will involve field, area and state level coordination.

# Environmental Quality Incentives Program (EQIP)

The sign up deadline for EQIP applications has been extended to **January 22<sup>nd</sup>** to be considered for FY-16 funding. Funding is available to address cropland, grazing land, confined livestock, drainage water management, nutrient management plans and wildlife habitat concerns. In addition to EQIP General the deadline applies to the following initiatives:

• EQIP Conservation Activity Plans

- National Water Quality Initiative (NWQI)
- Mississippi River Basin Healthy Watersheds Initiative (MRBI)
- National Organic Initiative
- National On-Farm Energy Initiative
- Great Lakes Restoration Initiative (GLRI)

# USDA National Agricultural Statistics Service (NASS) Conservation Effects Assessment Project (CEAP) Survey

As part of a national CEAP study, USDA National Agricultural Statistics Service (NASS) is contacting farmers to provide input on conservation practices on cultivated and non-cultivated agricultural lands. Data obtained from the project will help NRCS and partners determine the efficiency and effectiveness of current conservation techniques and help identify best practices.

NASS has started the interview process with producers to conduct detail surveys to gather information on field level management on behalf of NRCS. This interview process will continue through February. Field offices may get calls from landowners expressing concern about legitimacy, confidentiality or use. NASS representatives visit selected farms to collect information, such as on-farm practices; chemical, fertilizer and manure applications; integrated pest management; and installed conservation practices. As with all NASS surveys, respondents are guaranteed by law (Title 7. U.S. Code, and CIPSEA, Public Law 107-347) that their individual information will be kept confidential. No one representing NASS will ask a producer for personal information, such as social security number.

NRCS' component of the survey, the Supplemental Survey, will be completed by the Field Office staff and will begin in January2016 after the field staff is trained, NRCS should complete all of these surveys by April 13, 2016.
