1993 CONSERVATION COMPLIANCE

This may be one of the most important articles that you read this year. PLEASE READ THIS VERY CAREFULLY!

If you own or farm highly erodible land (HEL), you need to seriously consider all of the following questions:

*Does your conservation compliance plan(s) require "CONSERVATION TILLAGE SYSTEM", "CROP RESIDUE USE" or other practices to be applied in 1993? Where the Planned column shows 1993, the practice(s) must be applied in 1993 on the HEL fields indicated in the plan(s). All applied practices must continue to be applied or maintained in all of the following years that are applicable.

*Does your plan(s) require a percentage of residue cover on the ground surface after your crops

are planted in spring 1993?

Many conservation

compliance
plans require
40% residue
cover after planting
corn or 50% residue
after planting beans in a
corn-bean rotation. You must

understand your plan(s) and understand that the crop residue cover percentages are minimums!

*Do you plan to do any tillage to eliminate RUTS resulting from wet soil conditions at harvest? Tillage to eliminate ruts should be documented in your compliance plan for HEL Fields with SCS before doing tillage this spring. Contact your local SCS staff to document need for tillage. Deep tillage in spring has little or no effect in reducing compaction!

*Can you measure your crop residue cover on your fields after planting this spring to determine that it meets your plan(s) requirements? Your local Cooperative Extension Service and Soil Conservation Service offices have printed instructions on how to measure and determine the amount of residue cover on the ground surface after planting. Now is the time to learn how to measure and determine crop residue cover percentages!

*Do you plan to farm any new tracts this year that may have highly erodible land (HEL)? Check with your local SCS & ASCS office. You must adopt the previous plan or revise the plan before planting the 1993 crop!

APPLYING YOUR CONSERVATION PLAN(S) IS YOUR RESPONSIBILITY! DON'T WAIT, CHECK YOUR PLAN NOW!

IS MINE REALLY THE BEST?

Lately, a lot of farmers have been changing or upgrading their tillage techniques to be more economically competitive. With all these changes going on, and new things being tried, questions farmers are asking themselves more and more is: "Is the tillage system I'm using really the best wallet?", "Am I making the most of my pesticide and fertilizer programs?" or "How do I compare with my neighbors?" If you find yourself asking these questions, there may be a program just for you to help answer these questions.

The MAX program (Farming for Maximum Efficiency) is a bottom line "yield contest" that lets you evaluate the economic returns for the various tillage system used on individual fields with summaries of other fields across the state by using standardized cost. Keeping soil erosion losses below "T" values protects the future productivity of the land, and prevents water quality damage due to off-site sediment carried in run-off water. The tracking of fertilizers, pesticides, tillage trips and other crop inputs to help ensure the most cost efficient system.

If this exciting, innovative and simple program sounds like something you can use, or if you would like more information on it, please contact your local Soil and Water Conservation District, or the Soil Conservation Service. The entry deadline is June 1st.

IT'S CALLED FOLLOW-UP!

If you see a stranger in the distance walking across some fields with pen and paper in hand, he or she may just be one of our folks from the Soil Conservation Service, taking a look a ways to improve: soil erosion, water and air quality, and plant and animal life in the Kankakee Watershed. We will also be talking to landowners to see if we can further our exposure and cooperative

arrangements via conservation planning to improve the natural resources in St. Joseph County.
